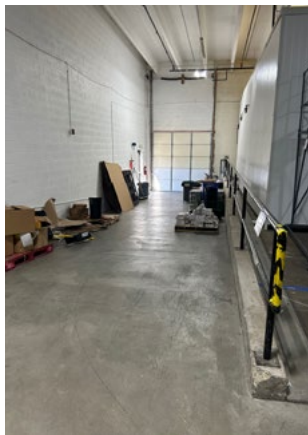
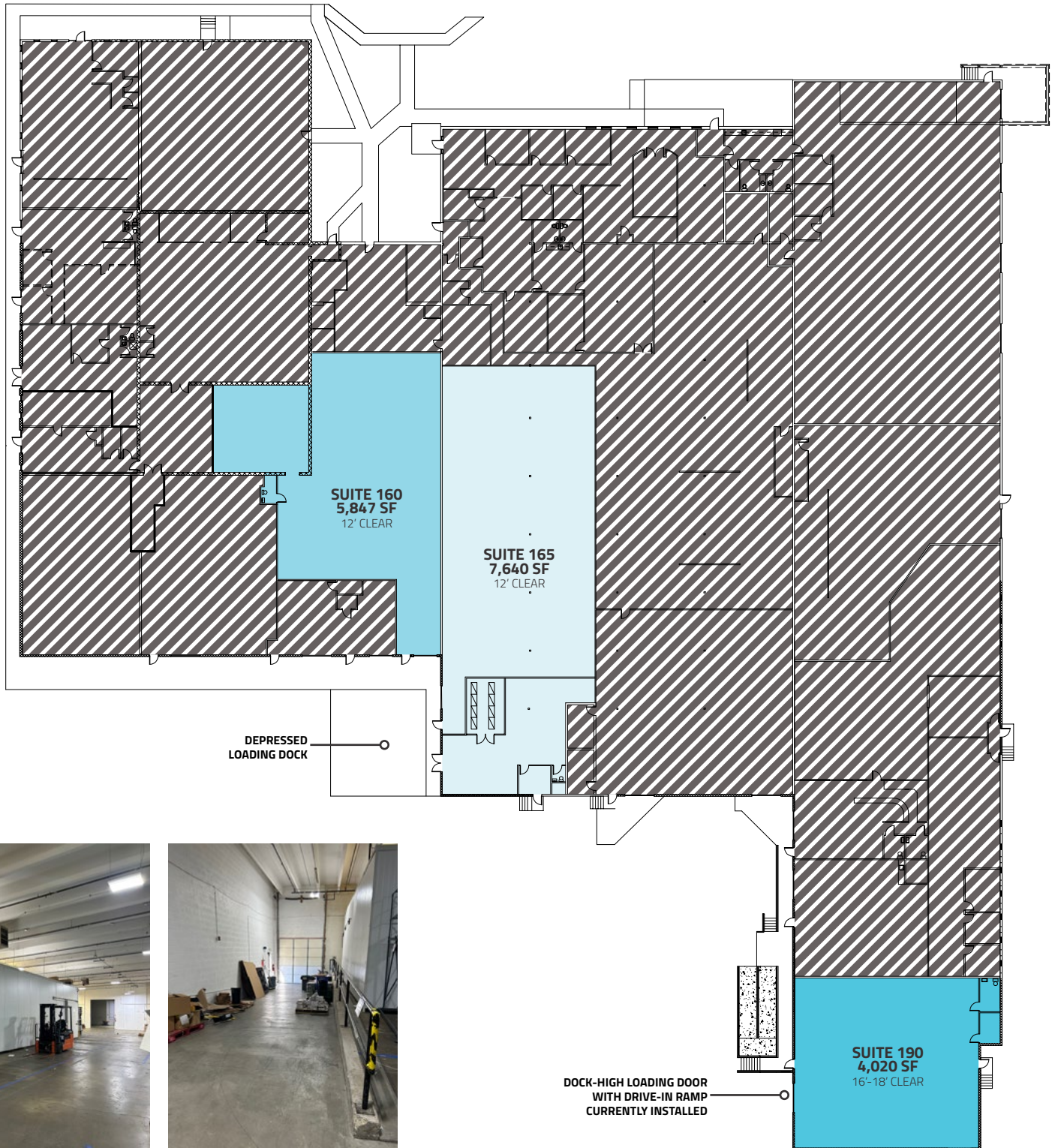

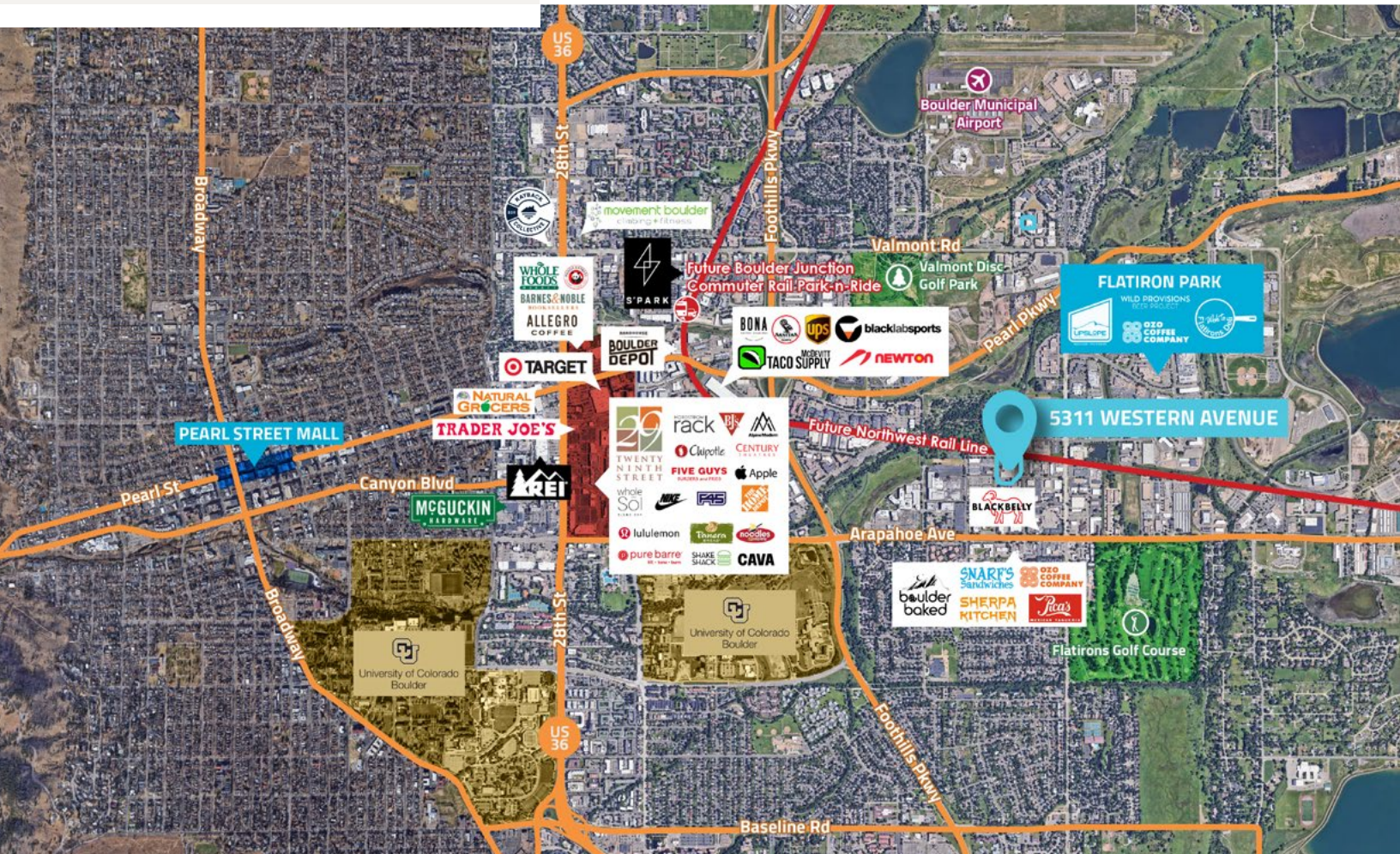
FLOOR PLAN
