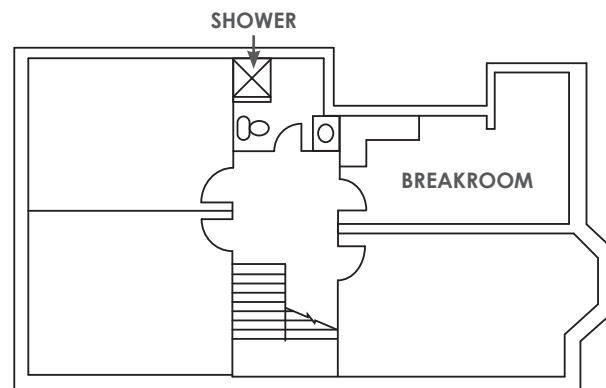

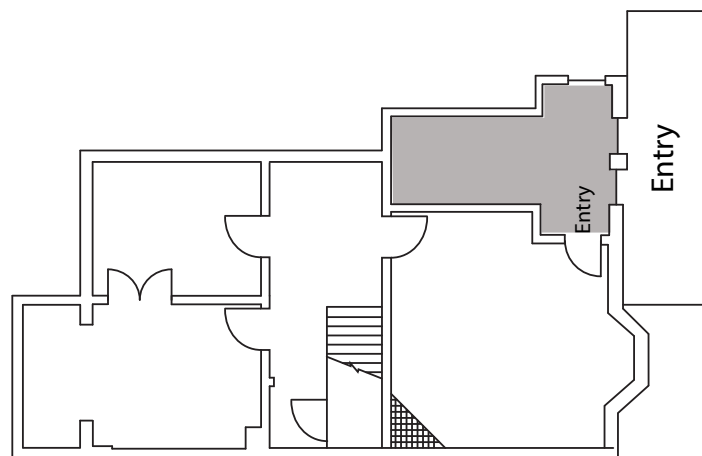

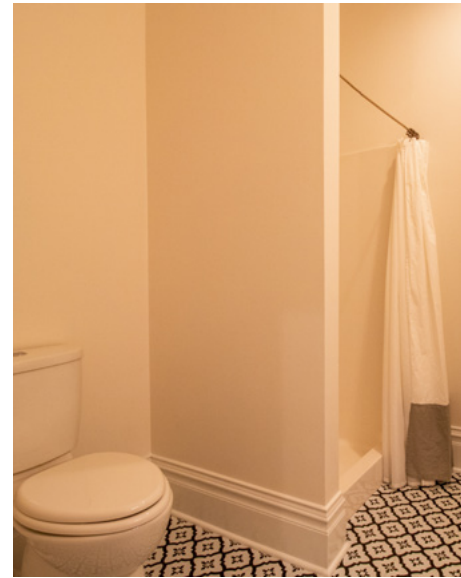


MAIN FLOOR
